Services - Analysis of the insurance situation of the customer

- Thorough check-up of any existing portfolio
- Analysis of current conditions, research and identification of the best economic structure and regulations.
- Identifying potential areas of risk which have not yet been secured and proposals for possible coverage.
- Identifying a common expiry date for all policies in order to ensure greater security and more efficient administrative management.



Services – Assistance in the drafting of contracts
